## **ELIGIBILITY**

In order to be eligible for D CLUB membership, the applicant must have be an active racer (skipper or crew) who participates in at least 50% of scheduled club races in one of the dinghy classes designated by the club.

## **WAIVER OF LIABILITY**

The owner, or prospective owner, hereby acknowledges that it is a condition of the use of the Club's harbours and premises, services or privileges that watercraft and other property personally owned by him or her, or ostensibly his or her property by reason of being in or on the harbours and premises on his or her invitation, with his or her acquiescence, or in his/her care, or watercraft operated by him or her although not his/her property, or while in the custody of (by bailment or otherwise) or in the control of or in the harbours and premises of the Club are at all times at his/her risk and that the Club and its employees do not incur any liability at law for loss or damages to such property for any cause whatsoever.

## **TERMS AND CONDITIONS**

D CLUB members will enjoy full club privileges.

- Must be Lightning or Laser sailor
  - If additional fleets wish to join the D Club they must join with 3 or more active boats. Any new fleets will have to be accepted by the D CLUB executive
- Entrance fees – none
- Membership dues
  - Graduated fees based on age up to a maximum of \$703.

- Full time students will be eligible for a reduced fee of \$275.
- Boat fees – Dinghy owners will be charged seasonal storage
  - \$260 for Lightnings
  - \$184 for Lasers
  - Additional fleets storage fees will be decided upon on the fleets review
- Monthly minimum house purchases – an account charge of \$15 for members 18 to 25+ and \$60 will apply per month to D CLUB members aged 30 and above in the year the member turns 30.

- Members of the D CLUB must commit to **10 hours** of yacht club community engagement per year. This may include race committee the evening series or weekend regattas, work on the D Dorm, refurbishing club lasers, etc.
- D CLUB members are not eligible to vote at RStLYC annual meeting or be on the RStLYC executive.
- D CLUB members are not eligible to have a boat on the main docks or in the harbor.
- If D CLUB members do not meet the 50% eligibility participation requirement they will be billed for a full membership
- If full members transfer to the D CLUB and either the D CLUB is not successful or the fleet does not meet participation requirements they will be moved to a full membership
- Full members are eligible to race in the D CLUB and partake in D CLUB events.
